No. SW (G) 220/2010/1-4 ----- Application are invited from the candidates who are permanent resident of Meghalaya for Admission into the Certificate Course Training in Handloom Technology at Handloom Training, Mendipathar, East Garo Hills for the session 2010 – 2011 for self employment on successful completion of the Training Course.

Terms & Condition are as follows:

1. **Duration** : The duration of the Course is 2 (two) years commencing from 11th October 2010.
2. **Age Limit** : Applications should not be less than 18 yrs and not more than 27 yrs of age as on 1.1.2010 relaxable by 5 yrs incase of Scheduled Caste / Scheduled Tribe candidates/
3. **Eligibility criteria:**
 - (a) The Applicants should have passed Secondary School Certificate (SSC/SSLC/Std X) or any equivalent examination and above (preference will be given to the Class XII pass) with:-
 - (i) General Science or Physics, Chemistry in case of Class – XII.
 - (ii) Mathematic.
 - (iii) English.
 - (b) Passed in Single sitting and
 - (c) Secure Minimum 45% marks in aggregate (40% marks in Aggregate in case of SC/ST candidates) and 50% marks in Maths and Science put together (45% in Maths & Science put together for SC/ST candidates) with English as a subject of study.
4. **Permanent Residential:** Non tribal applicants should submit a permanent Residential Certificates issued by the Deputy Commissioner of their respective District without which their application will be summarily rejected.
5. **Selection** The selection of candidates will be made on the basis of personal Interview and Merit taking into account the marks secured in qualifying examination. The date of Interview will be held on 23/9/2010 at 11:00 A.M. in the office Chamber of the Director, Sericulture & Weaving, Meghalaya, Shillong for these candidates hailing from East to West Khasi Hills, Ri-Bhoi District and Jaiñtia Hills and on 28/9/2010 at 11:00 A.M in the office of Joint Director, Tura for those candidates hailing from East, West and South Garo Hills. The candidates should note that no individuals call letter will be issued by the office.
6. **Course Fees** The selected candidates will have to bear the course fees of Rs. 2500/- (Rupees Two thousand and five hundred) only in case of ST/SC and Rs.3,000/- (Rupees Three thousand) only in case of Non Tribal candidates.

Besides, the above course fees, the selected candidates will also have to pay the Hostel fees etc., in the Principal of the Institute.
7. **Accommodation** Accommodation will be provided in the Hostel of the Institute.
8. **Stipend** The selected candidates will be awarded a monthly stipend of Rs. 600 (Rupees Six hundred) only subject to satisfactory progress good conduct and regular attendance. In addition, the trainees will be paid travelling expenses as admissible under the rules for study tour once in the complete training course.

9. **Job assurance** As the training course is confined strictly on self employment, the Department does not bind itself in providing Job after successful completion of the training and the applicants should note that He/She will not claim any job in the Department. The Selected candidates should execute the undertaking for the purpose.
